- -Winter FHA Workshop, Saturday, March 25, 2023, 9:00 a.m. 12:00 p.m.: This date was agreeable to all board members.
- -Reminder: Public housing public hearing 3/20/23 at 4:30 p.m.: Bobbi Richards said that the DHCD budget and perhaps the federal budget would be reviewed and the meeting would likely be a long one.
- -Kathleen Haynes said that she thought that Michael Galasso had a conflict of interest because of his business dealings and his role as a Commissioner. He would have prior knowledge of RFPs coming out ahead of the public; he is receiving funding for Megansett Place from DHCD. This raised questions that need to be talked about. Haynes believes it raises questions and should be discussed as an agenda item in the future. Favulli shared that public comment is not a place where deliberations occur. Haynes indicated that she would like to be on the record regarding her comment.

Maintenance Department update and portfolio review

- Michael Coffey reviewed the portfolio.
- -Rose Morin Windows Replacement VOTE

Bobbi Richards explained that the lowest bidder's offer, which was not complete, exceeded the half million dollars allocated for the project. Funds can be pulled from other areas to cover some of the increased costs. The goal is to go out to bid again in 30-45 days. Michael Galasso expressed concern that the bids were too high. It was noted that the property is in a flood zone and there are requirements that have to be met such as tempered windows. Patricia Favulli reminded that the project has been in the works for 3 years and costs have increased significantly during this time.

The next step will be to have a consultant review and make sure that nothing was missed. Michael Galasso questioned the need for a consultant. Michael Coffey was involved in the process and held a bidders' conference. Asbestos testing is being performed at the property.
