<u>241 Scranton Ave</u> – Lawrence O'Brien (Abutter) and Flynn Law & Associates, PC (FHA) - VOTE

Needed still, to make an informed decision, is an independent third-party survey. Bobbi Richards reported that immediately after the last meeting she sought an engineer to do the survey. Of several queried, only David Martin responded. He said the wait time before the survey is done is 4-6 weeks.

Lawrence O'Brien said that BSS did a survey in the year 2000 or so, commissioned by FHA, that established the property line between FHA and 241 Scranton Avenue. He said that the sidewalk is covering the bound. The whereabouts of the survey are unknown.

Bobbi Richards noted that this was the first mention of this survey. She has reached out to BSS and will do so again with a specific focus on this survey from about the year 2000. The surveyor will be informed of the urgency.

Maintenance Department update and portfolio review

-Occupancy Report

Bobbi Richards reported only 5 units as vacant. Two people had passed away and others had moved to a higher level of car. One tenant had been with the FHA for 19 years.

-44 Caroline

The board took note of Michael Coffey's memo regarding structural concerns about this property. The board agreed that DHCD should be asked to further consider this property and

that doing the work in-house as DHCD had recommended was not sufficient and could pose safety concerns.
