DHCD State Year-End Certifications – VOTE

Teresa Ewald explained that this presentation and review of DHCD material is done every year for the certification process. A review of each program included the following:

-4001: The reserves are not quite at the 35% that is the minimum. Administrative costs and employee benefits have been moved to other programs as flexibility allows, bringing the reserves to 34.94% which can be rounded to the 35% bringing the reserves to where they need to be. The year was finished a little better than it was at the start.

The program is not in strong financial shape but this has been the status quo for many years and the bills are able to be paid.

Bobbi Richards added that DHCD has released more monies recently and has been responding in a way it has not done previously and FHA has been able to go in and repair units fully.

-689: There is \$36,000 in reserves and operationally, the FHA has lived withing its limits.

-MRVP: A small amount has been made and reserves are at \$36,000.

In general, a 50% reserve or about 3-4 months would be a good goal.
