## **Public Comments**

### Maintenance Department

Low bid Zander Corporation, \$26,000, VOTE

Bobbi Richards noted that the task was to review the low bid for this federal project at Harborview.

Architect, Chris Kicza said that the bathroom in this ground floor unit at Harborview met earlier ADA standards but not the ADA or Massachusetts standards of today. In response to comments from the Board, the proposal was reduced to a minimum with a roll in shower and a shower and floor drain. Despite efforts to generate interest in bidding, only 2 bids were received with Zander the low bidder at \$26,000.

Michael Galasso asked how Winslow evaluates bids. Is there a breakdown of costs? A lump sum of \$26,000 can't be evaluated.

Chris Kicza was unsure whether there was a provision in Massachusetts law that permitted breaking down the costs. He noted that the proposal sets minimum requirements. Materials are

Patricia Favulli said that prevailing wages must be used.

Michael Galasso asked how contractors are bound to the schedule. Can 10% be withheld? Chris Kicza said that in any case, payments to the contractor usually are made months after completion.

Steve Patton noted that this was a sealed bid.

Patricia Favulli added that there was considerable information in the RFP as well.
